4. Payment may be made via Zelle, wire transfer, cash, check or via credit card.

**If paying by credit card, a 3.5% processing fee will be applied.** Once registration has been received, an invoice will be generated for with payment details. Reservation will not be considered complete until a deposit has been given.



**CANCELLATION POLICY:**

If cancellation is received in our office:

1. From the date of payment: \$250 is non-refundable.
2. Between August 27, 2019, and September 26, 2019, an additional \$1,000 per person will be charged.
3. From September 27 forward– full payment will be charged.
