PASSPORT / VISA INFORMATION:

Passports must be valid for at least six months from the date of departure from the USA.



TERMS OF PAYMENT FOR THE LAND PORTION:

1. A deposit of \$1000 per person is required to assure reservations. \$250 per person is nonrefundable.
2. August 27, 2019- 50% of the total amount balance is required.
3. Final and full payment is due by September 27, 2019
4. Payment may be made via Zelle, wire transfer, cash, check or via credit card.

If paying by credit card, a 3.5% processing fee will be applied. Once registration has been received, an invoice will be generated for with payment details. Reservation will not be considered complete until a deposit has been given.

CANCELLATION POLICY:

If cancellation is received in our office:

1. From the date of payment: \$250 is non-refundable.
2. Between August 27, 2019, and September 26, 2019, an additional \$1,000 per person will be charged.
3. From September 27 forward– full payment will be charged.
